Also present, District Clerk, Ronda Barton; Alliance Vice-President, Tony Sneed; Alliance Local Manager, Tyler Stuhlman; District Attorney, Mark Piontek of Sandberg Phoenix & VonGontard P.C; and District Engineer, Mark Bross of Klingner & Associates.

The meeting was called to order and presided over by President, Martin Judlowe.

Mr. Judlowe called for review of the July 26, 2022, Open Regular Session meeting minutes. Having no questions or discussion, Mr. Behl motioned to accept the July 26, 2022, Open Regular Session meeting minutes. Mr. Sergent seconded. All ayes. Motion carried.

Furthering, the Norwoods WWTP ammonia remains out of compliance; DNR recognizes the district's efforts for funding of update to the system. THM's were also high however, results were within compliance and is based on a 3-month average. Discussion occurred on benefits and timing of switching wells.
